<u>State Budget:</u> The Ohio Senate is underway with hearings on HB 225, the state biennium operating budget. Relevant committees are currently holding hearings with various state departments. The Department of Developmental Disabilities (DODD) will testify in the <u>Senate Medicaid Committee</u> later this month, we expect the week of April 28th. If you happen to live or provide services in the districts of any of the committee members, we encourage your advocacy and are happy to help you connect if needed. We will coordinate additional testimony opportunities with our budget coalition as there may be opportunities for in-person as well as written member testimony. <u>Federal Budget:</u> Congress is on recess, following last week's passage of <u>a concurrent budget resolution</u>. The resolution still instructs the House Energy and Commerce Committee (which oversees Medicaid funding) to cut \$880B over the next decade. This week we saw a <u>dozen Republican legislators sign onto a letter</u> urging House leadership not to make significant cuts to Medicaid, citing the harm to vulnerable populations and state health systems. The relevant committees have a deadline of May 9th to submit their proposals to their respective leadership. OPRA will continue to advocate for solutions that do not impact disability services.

<u>Trade Meeting:</u> This week Pete and Rachel met with the ICF Trade Association group that also includes ODH. It was reported by ODH that they continue to focus on their plan of completing all recertifications and are working to get between 20-30 recertifications done per month to address the backlog.

HB 225: This week saw the introduction of House Bill 225, The 'Employment First and Greater Opportunities Act'. The bill, sponsored by Reps Dontavius Jarrells and Tom Young looks to eliminate commensurate wages over 5 years, while also supporting a tax credit to entities that purchase from qualified non-profit agencies that employ people with developmental disabilities. The bill is currently pending referral to the Commerce and Labor committee. Please reach out to Scott or Christine with any questions.
