<u>State Budget:</u> The Senate Medicaid Committee is scheduled to host testimony from the various state Directors over Medicaid services (JMOC, ODM, OOD, and DODD). After the Directors' testimony, the DD Budget Coalition will testify. We anticipate the panel will present at 2pm but may be delayed if the Director's testimony goes long. No other public testimony will be accepted this hearing. Public testimony, written and verbal, will be heard in the Committee on May 6th and 13th. More information on how to participate in the hearing is forthcoming from Christine. <u>You can livestream next week's hearing here.</u>

<u>HB 141 (PPEC)-</u> The House Health Committee will host a hearing on HB 141, a bill to create pediatric extended care centers, on Wednesday April 30th, at 10am. The Committee is expected to adopt an amendment to the proposed bill language after sponsor testimony. We believe there will be opportunity to provider public testimony over the next few weeks. We anticipate the bill will move quickly through committee and to the House floor for a vote. <u>You can read the bill text and LSC analysis here.</u> You should be able to watch the <u>livestream of the hearing here.</u>

<u>EVV:</u> The Ohio Department of Medicaid (ODM) is hosting an EVV Stakeholder meeting next Monday from 2:30pm to 4pm. <u>You can register for listen-only access here.</u>

Additionally, DODD and ODM will be convening a few small group discussions on developing strategies to best help DODD providers prepare for claims denials to be turned on in October. As preparation for this meeting, OPRA is looking for feedback from the Membership on their EVV experience. We will be scheduling a call open to all members to share their EVV concerns within the next few weeks. You can also send any EVV thoughts, concerns, and questions to Christine in the meantime.

<u>Budget Reconciliation:</u> Congress is back in session next week and relevant committees will take up it's work on the Budget Reconciliation bill, which includes the direction to make significant reductions to the Medicaid program. The expected 'markup' is likely due on May 7th. Our partners at ANCOR have set up <u>this Votervoice</u> <u>page to help send an immediate message</u> to your Senators and Representatives about the importance of Medicaid in disability services.

<u>CEO Network:</u> Thanks to everyone who attended and participated in this week's CEO/DOO Network meeting. The meeting was focused on the Gallup Workplace Engagement survey and strategies to enhance employee engagement. OPRA will develop some additional resources based on the discussion.
