<u>HB 96 (State Operating Budget)</u>: This week, the Senate passed HB 96 out of the Chamber. The Senate's version of the bill does include some changes from the version passed by the house, including an amendment establishing a study committee for Ohio's DD system. Overall, provider rates were not adjusted from the Governor's introduced budget earlier in the year, mostly maintaining current reimbursement rates for DD services. The bill now goes to conference committee for the two chambers to resolve any differences. During the Friday morning call, Christine provided an update on the budget provisions included in the Senate's version. #### Required DSP Compensation Reporting Due- Response rate is currently at 34% of providers.

#### Attention: Agency Providers of Homemaker, Personal Care and/or Day Services:

The annual Direct Support Professional (DSP) Compensation Survey is due June 25—less than one month away! DODD recommends starting the process as soon as possible to confirm delivery of your survey code and to avoid any potential delays in receiving technical assistance from DODD staff. If your agency did not receive a survey code, please contact <u>DSPComp@dodd.ohio.gov</u>. Recommended steps for success:

• Gather employment start and end dates for all DSPs who provided HPC or day services for any length of time in 2024.

• Gather 2024 payroll data for those employees using your agency's payroll reporting system and/or the final payroll stub issued to your DSPs in 2024.

- Review the PowerPoint and Excel workbook on DODD's website.
- <u>Watch a pre-recorded training</u>.

• Ask for assistance from your fiscal partners, who may include a chief financial officer (CFO), an accountant, and/or a billing agent.

• Periodically review your agency's contact information in Provider Network Management/Provider Service Management (PMN/PSM) to remain compliant and up to date with the latest DODD information.

• Send any questions to <u>DSPComp@dodd.ohio.gov</u>.

Independent providers and intermediate care facilities do not need to complete the survey.
