<u>State Budget/OBBBA Call:</u> Thank you to everyone who attended the member call regarding the recently passed state budget bill (HB 96) and the federal budget reconciliation bill (OBBBA). It was a lot of information to cover! For those who attended on Thursday, please note there has been a revision on slide 7 and 18- the DODD waiver and ICF appropriation chart. First, the GRF estimate used for 2025, was from the wrong ALI. It has been updated. We also added a row to the chart to show the ARPA HCBS enhanced FMAP funding for 2025. The final total for DODD spending on direct services for 2025 has been updated to reflect these changes. Click here to download the presentation
